

# VISION 2025

Increasing Christ Church's Impact

### VISION 2025 is about people and programs

- Five-year investment in people and programs at Christ Church, to enrich lives of current parishioners and to attract new members
- Conceived by Marek and then informed by parishioner feedback a large parishioner survey and multiple focus groups took place in January and February 2021 to ensure programs had parish input and support
- Aims to dramatically increase Christ Church's activity and size of our community









#### • Goals:

- Attract new members, especially young families
- Offer all parishioners more opportunities for worship, learning, fellowship and service

• Key Steps:

- Hire seven new staff members to drive programs, fund for at least five years
- Add new programs and enhance existing programs



# Parish Focus Groups and Survey informed Vision 2025 programs

- 216 Parishioners completed an online survey, and 10 small discussion groups were conducted to determine:
  - What aspects of the Christ Church community best feed our spiritual journey
  - Where do we want to see the most growth in the coming years
- Key Learning:
  - Parish wide agreement for desire to grow, especially with respect to:
    - Young Families, Youth programs music and beyond, Diversity of membership
  - Five pillars of "joy" that Christ Church brings to its parish are:
    - Worship & Music
    - Community
    - Adult Spiritual formation
    - Outreach
    - Our campus



### Six Key Initiatives in Vision 2025

- Worship- New worship options and a stronger music program
- Spiritual Formation Enhanced learning opportunities for adults, youth, and children
- Outreach & Engagement Expanded opportunities to serve in and outside the parish
- Fellowship & Welcome- More ways to connect through events and hospitality
- Our Digital Future Delivering Christ Church worship and programs to a wider audience
- Stewardship Strong engagement and fundraising leadership to grow our programs



# Supporting Vision 2025



We have a goal of \$ 4.5 million for a five year program - that provides roughly \$ 900,000 a year for five years in additional spending for the new roles. This is on top of the spending enabled by the Annual Appeal.



We have already raised \$1.9 million, 42% of our \$4.5 million goal. This means that for 2022-2026 we are able to fund three roles that would not have been possible without this incremental funding.



During 2022 we will be talking to other donors about supporting Vision 2025 so we can put in place the full set of additional staffing.






### Endowment Commission (EC) Report

#### **Endowment Loan Paid-off in Full**

- •Vestry passed resolution in January 2020 to endeavor to pay off \$1,500,000 Endowment Loan on or before 12/31/23
- •Original plan was to pay down \$500,000/year from either liquidation of investments or other means
- •Payments of approximately \$500,000 were made in February 2020 and November 2020, with final pay-off in November, 2021... a full 2 years ahead of plan
- •Due to legacy gifts and market appreciation, net Endowment balance is today higher than before the loan repayment plan: recent balance \$11.7 million vs \$9.3 million at 1/1/20

#### **Endowment Performance**

- Absolute net returns have been +11%, +13.7%, +9.1% and +8.5% over the past 1, 3, 5 and 10 years
- The Endowment has slightly underperformed its primary benchmark, the JPMorgan Asset Allocation Index, which has generated returns of +13%, +14.4%, +10.1% and +8.7% over those same periods.
- The Endowment's historical allocation to higher beta, small and mid cap equities and international equities has hindered relative performance over the last few years.



#### Endowment draw to drop from 4.5% to 4.0% over the next 5 years

- Vestry passed resolution at December 2021 Vestry meeting to decrease the Endowment draw, which is the stream of income from the endowment that funds a portion of Church operating expenses; Goal is to reduce draw to 4.0%, ratably over 5 years.
- The average US endowment draw is generally within a range of 3% to 5%, and over the years, Christ Church has been on the higher end of that range; this change is prudent in that it moves the Church closer to the midpoint of the range.
- The lower the draw from the Endowment, the more principal is available each year to generate market/investment returns and offset inflation. Ideally, the endowment can grow over time with market returns greater than the draw percentage and inflation.
- Our goal is to double the size of the Endowment over the current decade, which can be driven by market returns and new contributions, taking the form of legacy gifts and the like. The Endowment benefited from over \$1,000,000 in legacy gifts in 2021 alone.

# Arbor Society Report

- Arbor Society just entered its 25<sup>th</sup> year at Christ Church...and 3<sup>rd</sup> year of relaunch. Recognizes those parishioners who have decided to leave assets to the Church through their will or estate plan.
- Living and deceased members total 84 at year, with 8 joining last year.
- Actively encouraging parishioners to consider joining the Arbor Society...no gift is too small
- Proclaiming February as "Arbor Society Month" at Christ Church
- Updated Arbor Society leaflet, webpage and relocated the member recognition plaques; stepped up visibility, have improved messaging and begun to share testimonials of why members are moved to give
- Recently sponsored an estate planning seminar at a Sunday Forum, with estate expert David Wilfert guest speaker
- Received legacy gifts in excess of \$1,000,000 in calendar 2021, which meaningfully boosted the net Endowment fund balance

## **2021 Financial Accomplishments**

- Parish finances remained stable thru continuing pandemic  $\hfill\square$ 
  - Annual Appeal \$1.76m (94.6% of budgeted goal)
  - □• Plate exceeded budget: \$103k v \$70k
  - Payroll Protection Program ("PPP") loan converted to a grant: CCG: \$276k, NSCC (\$135k) and Bookstore (\$20k)
- Paid off Line of Credit CCG is debt-free!
- Raised funds for Harrison & Harrison Organ ~\$3.5m
- Further reduced endowment draw (4.6% to 4.5%)
- Year-end cash on hand of 935kv 890k at YE 2020) 4
